### **Preparing your Entry**

### **Entry Fees (per entry)**

SEDA Members: no charge

Non-Members: \$150 plus GST. Credit Card, cheque or EFT is accepted.

#### How to prepare your entry:

- 1. Refer to the Award Category Descriptions and Judging Criteria.
- 2. Prepare a narrative entry using the Submission Outline provided for each Award Category.
- 3. Submit entry via email to seda@seda.ca along with supporting materials.

## **Economic Development Project**

Two awards will be given based on the project's overall impact (population under 5000 and over 5000).

This award recognizes a project or program that has had a socio- economic impact on a community or region.

### Examples of initiatives:

- Investment attraction
- Business retention and expansion
- Entrepreneurship
- Planning and strategic development
- Sustainable and green development
- Real estate development or downtown revitalization
- Tourist attraction and tourism product development
- Workforce development and resident attraction
- Innovation in community resiliency
- Inclusive community based initiatives and programs

UNIQUENESS: What makes this initiative unique in its design, content or delivery? Could it be a model or best practice for the industry or other communities? Did it employ new technology or environmental elements?

INCLUSIVENESS: Is the project inclusive and accessible to a broad target audience? if so, illustrate how and include partners, if applicable.

# **Marketing & Communications Award**

Two awards will be given based on the project's overall impact (population under 5000 and over 5000).

This award recognizes marketing initiatives, campaigns or materials used to make a positive socio-economic contribution locally, regionally or provincially.

# **Leadership Awards**

### Professional of the Year

This award recognizes a Community and Economic Development practitioner in Saskatchewan. It rewards excellence in the field of economic development in the context of economic and social contribution locally, regionally or provincially.

Individuals who are engaged as a professional, technical or management or position in the field of economic development in Saskatchewan may be nominated.

- Positive impact on other practitioners in economic development.

Letters of support are encouraged.

# Community Influencer of the Year and

# Diversity, Equity and Inclusion Influencer of the Year

These two leadership categories reflect the importance of a positive influence within the community and economic development ecosystem. Submissions will be accepted by and on behalf of individuals who have made a significant impact on their peers, their industry their community and/or the overall economic development ecosystem.

**Community Influencer of the Year -** awarded to a community leader (elected or informal).

**Diversity, Equity and Inclusion Influencer of the Year** - awarded to a leader or a professional who has advanced diversity, inclusion and equity in their organization and/or community or region.

# John P. Sutherland Lifetime Achievement Award

The late John P. Sutherland, long-time employee for the Canadian National Railway, was instrumental in the establishment of and fundraising for the Saskatchewan Economic Development Alliance (SEDA). His personal commitment to and support of the Alliance and its members have had a lasting impact on economic development in Saskatchewan.

The award recognizes lifetime achievement and excellence within the field of community and economic development in Saskatchewan.

The following criteria will be considered in the adjudication process:

- 1. Consistent exemplary performance in the economic development profession for at least 20 years.
- 2. Innovative and effective business skills and leadership in executing economic development projects that have had a significant impact on communities.
- 3.A widespread and positive impact on other practitioners in development with whom the nominee has had contact.
- 4. Voluntary involvement at a local, regional or provincial level.
- 5. Awards and other recognition conveyed.

# Chairperson's Award

SEDA extends a SPECIAL RECOGNITION award each year to recognize individuals, organizations or communities who have demonstrated a multiyear commitment to the vitality, growth and sustainability of their locale and the province.

If appropriate, speak to the objectives, impacts, population served, uniqueness and inclusiveness of the initiative or efforts of the individual being nominated.



## **Frequently Asked Questions**

### Who judges the awards?

An independent panel of judges is convened every year. SEDA draws from its member and partner network provincially and nationally.

### We are not a SEDA member, can we submit an entry?

Awards are open to all individuals, organizations, partnerships and jurisdictions within the Province of Saskatchewan. Consultants may submit an entry provided they have permission from the client organization or community.

Entries must have been produced or implemented between January 2023 and April 2024.

### Can I submit for multiple awards?

Your organization may submit multiple submissions for the same category. A separate Entry Fee (if applicable) is required for each.

### Can I use one project for multiple awards categories?

Yes, submitting an initiative in multiple categories is acceptable.

#### Can I submit an entry on behalf of another organization or person?

If you are submitting on behalf of another organization/person, you are required to notify the other party. The nominated organization/individual must be a SEDA member in order to have the entry fee waived.

#### How do I submit a project with partners?

One of the project partners must make the submission on behalf of the group and must indicate all the partners involved. If the initiative is selected for an award, SEDA will provide one award to the submitting partners. Duplicate awards can be ordered by the award recipient or project partners at an additional cost.

### I am not sure which category to enter. Will this affect my submission?

If, after your submission is reviewed, it is found to be an incorrect category or better meets the criteria of a different category than originally entered, it will be moved to the appropriate one and the nominee will be notified.

#### How will I know that my entry has been received?

A confirmation email will be sent upon receipt of your entry.

### If I am nominated but do not win, will I still be recognized at the event?

SEDA will only announce all award recipients.



## **Submission Support**

Narrative submission outlines have been aligned with the award judging criteria. Following the outlines provided will ensure your entry receives full consideration by the panel of independent judges.
