Scope of Work

The successful consultant will be responsible for the following:

Phase 1: Community SWOT Analysis

- Conduct a comprehensive assessment of Weyburn's economic landscape.
- Identify key strengths, weaknesses, opportunities, and threats relevant to business development and investment.
- Engage local stakeholders, including businesses, government officials, and community organizations, through surveys, interviews or focus groups.
- Analyze demographic, workforce, infrastructure and market trends.
- Deliver a detailed SWOT report with key findings and insights.

Phase 2: Industry Cluster Development Strategy

- Based on SWOT findings, identify priority industry clusters for development.
- Assess economic viability and competitive advantages of each recommended cluster.
- Develop a strategic action plan to attract and grow targeted industry sectors.
- Provide recommendations for marketing, infrastructure, workforce development, and policy support needed for cluster growth.
- Identify potential funding sources and investment attraction strategies.
- Present final recommendations to WRED and key stakeholders.

Project Timeline

• Proposed schedule with major milestones and deliverables.

Budget Breakdown

- Itemized costs.
- Any additional expenses or contingencies.

Experience and References

- Examples of similar projects completed.
- At least three client references with contact information.

Deliverables

• Description of final reports, presentations, and materials to be provided.

Submission Format.

• Proposals must be submitted in PDF format.

Value adds

• Provide any other recommendations that would enhance the project

Evaluation Criteria

Proposals will be evaluated based on the following criteria:

• Experience & Qualifications (30%) – Demonstrated expertise in economic development, SWOT analysis and industry cluster strategy.
